

Hydrogen bond nets in dithionate metal salt crystals

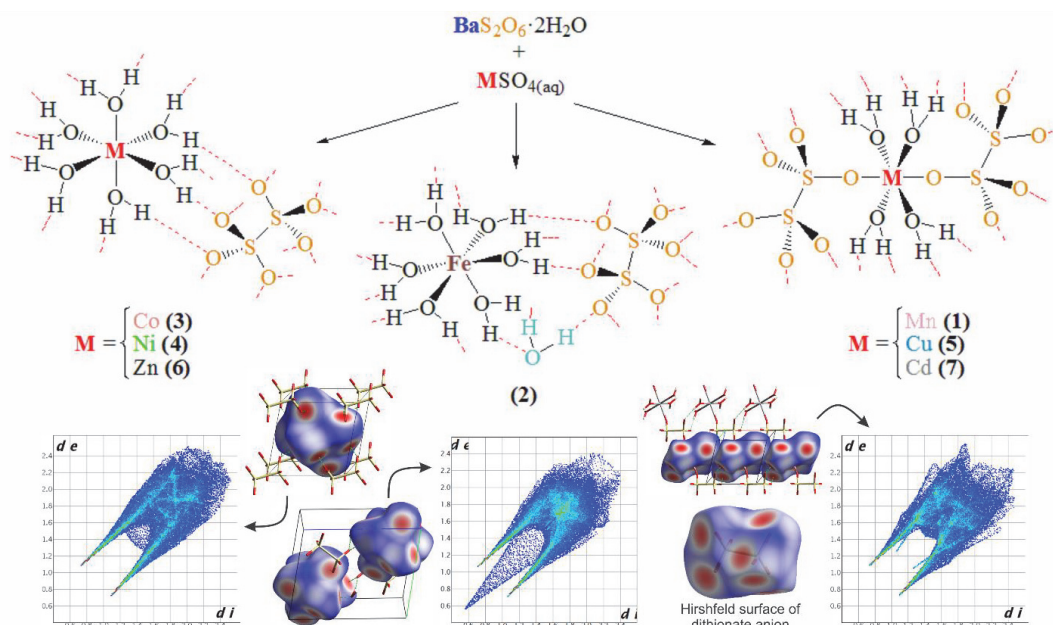


Figure 1. Synthetic scheme, Hirshfeld surfaces and fingerprint plots of complex salts and coordination polymers with the anion dithionate.

Seven dithionate aqua complexes of the transition metal ions Mn^{2+} , Fe^{2+} , Co^{2+} , Ni^{2+} , Cu^{2+} , Zn^{2+} and Cd^{2+} were synthesized and their crystal structures determined, giving three coordination polymers – *catena*-poly-[*trans*-tetraaquamanganese- μ -dithionato- $\kappa^2\text{O},\text{O}'$], $[\text{Mn}(\text{H}_2\text{O})_4(\text{S}_2\text{O}_6)]$ **1**, *catena*-poly-[*trans*-tetraaquacopper- μ -dithionato- $\kappa^2\text{O},\text{O}'$], $[\text{Cu}(\text{H}_2\text{O})_4(\text{S}_2\text{O}_6)]$, **5** and *catena*-poly-[*trans*-tetraaquacadmium- μ -dithionato- $\kappa^2\text{O},\text{O}'$], $[\text{Cd}(\text{H}_2\text{O})_4(\text{S}_2\text{O}_6)]$ **7** – and four complex salts – hexaaquairon(2+) dithionate hydrate, $[\text{Fe}(\text{H}_2\text{O})_6](\text{S}_2\text{O}_6)\cdot\text{H}_2\text{O}$ **2**, hexaaquacobalt(2+) dithionate, $[\text{Co}(\text{H}_2\text{O})_6](\text{S}_2\text{O}_6)$ **3**, hexaaquanickel(2+) dithionate, $[\text{Ni}(\text{H}_2\text{O})_6](\text{S}_2\text{O}_6)$ **4** and hexaaquazinc(2+) dithionate, $[\text{Zn}(\text{H}_2\text{O})_6](\text{S}_2\text{O}_6)$ **6**, Figure 1. All crystallized in the triclinic space group $P\bar{1}$. Hirshfeld surface fingerprint plots^{1–3} were used to map the interactions within the crystal structures. The structures were analyzed by Quantum Theory of Atoms in Molecules^{4,5} to determine the bond critical points and to estimate the energy of the hydrogen bonds. The structural differences were rationalized using Pauling packing rules.⁶
